### **Terms & Conditions:**

This agreement is good for one full calendar year, from the date of contract, with a minimum of one full year of service. These services must be performed on the same vehicle for the entire length of the contract. In the event that the client sells and purchases a new vehicle in this time period, a new contract must be signed for the remaining time left on the contract. The customer is responsible for all charges even if they no longer wish to have us service the vehicle. By agreeing to this plan the customer is entering into a contract with Obsessive Compulsive Detailing, LLC.

You may choose to pay for the Mental Wellness Plan in one of four ways. You may have the yearly cost paid all at once after the first detail service is performed on the plan, pay 12 equal payments monthly, 4 equal payments quarterly, or 2 semi-annual payments. The total price will be determined by which wellness plan you select. Obsessive Compulsive Detailing requires that the customer have a valid credit card on file. However, the customer may pay with any form of valid payment at time of due date.
